Elkhart Lake School District Administrator Ann Buechel Haach attended the meeting to explain the referendum that will be on the April 7, 2015 ballot to borrow \$2,900,000. The last loan that was for 5 years was paid off in 3 years. The new loan would be used to upgrade and replace the HVAC systems and other needed upgrades.

Ephraim Yoder attended the meeting because he is interested in buying a lot on the west side of County Highway H going south out of St. Anna. The Clerk verified the agenda was posted. The minutes of the previous monthly meeting were read. Schmahl moved to accept the minutes as read. Ausloos seconds the motion. Motion carried.

The treasurer's report was read. Ausloos moved to accept the treasurer's report as read. Schmahl seconds the motion. Motion carried.

The monthly bills were presented to the board. Schmahl moved to pay all the bills. Ausloos seconds the motion. Motion carried.

The building permits issued in the last month to Stanley Meinnert and James Drake were reviewed by the board. James Drake is putting an addition to his milking parlor. The parlor would be 76 feet from Drake Ct. A building housing animals should be 100 feet from the center of the road. The town planning board determined that a milking parlor does not house cows. The cows go in, get milked and they go out. After some discussion, the town board agreed with this decision. Schmahl then moved to approve the building permit. Ausloos seconds the motion. Motion carried.

A question was also asked about the remolding of Scrubs Bar & Grill by the new owner. Being a bar, does he need a state inspection? The clerk will check with Brandon Jovonowich when he issues his liquor license before he opens for business.

Mark Buechel attended the meeting. He asked if the town board would allow 4 wheelers on town roads. Some towns have passed an ordinance that allows 4 wheelers on certain town roads. The town board will check into this issue before making a decision.

The recycling center was discussed. Some silage bags are still being put in the garbage dumpster.

Two members of the St. Cloud Fire Department attended the meeting. The current contract with the fire department has come to an end. It was for \$1,600 a year. The St. Cloud Fire Department proposed a contract for 5 years at \$1,700 a year and reviewing the contract after 3 years. After some discussion, Schmahl moved to accept a 5 year contract at \$1,700 a year and review the contract after 3 years. Ausloos seconds the motion. Motion carried. The St. Cloud Fire Department will write up the new contract.

The constable reported that he was approached by some individual about a right-of-way from the north end of High view Rd. to the DNR owned land in the Town of Russell. Schmahl moved to appoint Jerrod Henshcel as Zoning Administrator with a pay of \$35.00 a meeting and a salary to be determined after his duties are established. Ausloos seconds the motion. Motion carried.

The operator license application of Michelle Jeanty was reviewed by the board. Ausloos moved to approve the operator license. Schmahl seconds the motion. Motion carried.

The town board will discuss the IOH permits. The town may have to issue some permits.

The town treasurer will be sending a notice to the town residents that are late with their dog license.

Jeff Sanders will be asked to attend a planning board meeting to answer questions about issues with redoing the ordinance manual.

There being no other business, Schmahl moved to adjourn. Ausloos seconds the motion. Motion carried. Meeting adjourned.

ANNUAL MEETING APRIL 21, 2015

Chairman Terrance Winkel called the meeting to order followed by the Pledge of Allegiance. There were 17 town residents present.

The minutes of the April 15, 2014 annual meeting were read. Gary Seiler moved to accept the minutes as read. Daniel Schmahl seconds the motion. Motion carried.

The annual report was reviewed and discussed. Pat Zorn moved to accept the annual report as printed. Mark Schurich seconds the motion. Motion carried.

Kenneth Turba moved that the town board attend the WTA State Convention with the town paying the expenses. Gordon Horn seconds the motion. Motion carried.

Tri-County News is the town paper. Pat Zorn moved to designate Tri-County New's as the town paper. Mark Schurich seconds the motion. Motion carried.

Bank 1st National is the town bank. Pat Zorn moved to designate Bank 1st National as the town bank. Gary Seiler seconds the motion. Motion carried.

The recycling center was discussed. The new hours of 8:00a.m. to 11:00a.m. are working. The DNR inspected the old landfill in the fall of 2014. The DNR recommended that the grass gets cut and the trees that are growing on the landfill be cut down. The St. Anna Fire Department has been asked to burn the grass and then the trees will be cut and the ground leveled so the grass can be cut once a year. It was asked if an updated recycling list could be obtained.

The town roads were discussed. The town board has checked the roads. Holstein Rd. between Sheboygan Rd. and County Highway H and Sexton Rd. between Sheboygan Rd. and County Highway H and Sexton Rd. between Sheboygan Rd. and County Highway H may be resurfaced this year. The snow plowing bill for the winter was low. The Town borrowed \$30,000 last year to pay the road repair. Because the Town borrowed the money, the payments will not affect the State Levy Limits.

The fire signs installed in 2009 are faded. Chairman Winkel is checking with Shewin Industries and Keith Zipwick about replacing the signs. A culvert on Sexton Rd. north of County Highway H and one on Horn Ct. will be checked by the Town Board.

Supervisor Ausloos has cut brush on Anderson St. The town board will be checking on cutting brush of some town roads

The board was asked if ATV's could travel on town roads. The board will be checking with some other towns that have passed an ordinance that allows ATV's on town roads.

The Elkhart Lake Triathlon will be held on June 13, 2015. Part of the bike race will be held in the Town of Russell.

IOH was discussed. The town has gone with Option F. Sheboygan County and other Town's have also gone with Option F. A permit would be needed for hauling over 92,000 pounds.

A concern about manure on the road was stated. Manure should be cleaned off the road when they are done hauling or if there is to much during hauling. The farmer should be asked first to clean up the manure. If the farmer doesn't clean up the manure, then they should talk to the town board.

The Open Book will be held on May 7, 2015 from 4:00p.m. to 6:00p.m.

The Board of Review will be held on May 21, 2015 from 6:00p.m. to 8:00p.m. or adjournment.

The date for the 2016 Annual Meeting was discussed. Jaremy Cobble moved to hold the Annual Meeting on April 19, 2016 at 7:00p.m. Stanley Meinnert seconds the motion. Motion carried.

Dan Schmahl explained what the planning board is doing updating the Ordinance Manual. Jerrod Henschel has been appointed as Zoning Administrator. His duties are still being discussed. There will be a planning board meeting on April 29, 2015 at 7:00p.m. Jeffrey Sanders, Planning Consultant, will attend the meeting.

Kenneth Turba was thanked for his years as building inspector. He will help Jerrod to learn his new duties.

The town board encouraged the town residents to check the town web site.

Clerk Kempf has been appointed for a term of 2 years as town clerk. This will be his last term, so the board will be looking for a new clerk in two years.

There being no other business, Pat Zorn moved to adjourn. Jaremy Cobble seconds the motion. Motion carried. Annual Meeting adjourned. The following oaths of office were taken. Chairperson – Terrance Winkel. Treasurer- Jaremy Cobble Supervisor – Daniel Schmahl Supervisor – Jonathon Ausloos Constable – Jonathon Ausloos Clerk – Lawrence Kempf Refreshments followed.

Richland Kraus and Jacqueline Samse were present at the meeting about her late dog license fee. After May 1, 2015, there is an extra late fee. Because Jacqueline came to the town board to explain why she was late with her payment, Ausloos moved to allow her to pay just the regular late fee and not the late fee that starts on May 1, 2015. Schmahl seconds the motion. Motion carried.

Richard Kraus reported that there are 2 dogs in the area that are causing problems. These 2 dogs are not licensed in the Town. The constable will check on these dogs as to why the owners did not get a license and if the dogs have had their rabies shot.

The monthly bills were presented to the board. Ausloos moved to pay all the bills. Schmahl seconds the motion. Motion carried.

There were no building permits issued in the last month.

The recycling center was discussed. One town resident is still bringing silage bags. The DNR has called the clerk to see if the work on the old land fill was done. The clerk told him that the fire department was asked to burn the grass but they did not do it yet. He will call back in 3 weeks.

The constable reported that he is working on the late dog license. He has called the district attorney and complained about the individual who has not paid his dog license from last year. The county gets the dog license money but the county does not do their job in collecting the money when a person does not pay the dog license.

The Open Book will be held on May 7, 2015 from 4:00p.m. to 6:00 p.m.

The town roads were discussed. Struct & Irwin Paving will check the roads they repaired last year. The faded fire signs that were installed in 2009 will be replaced at no cost. Town residents will be asked to replace their own sign. If the town board has to replace them, it will cost the person \$10.00. Supervisor Ausloos has cut brush on Anderson Ct. and he chipped some of the brush. He should give a bill to the clerk for the chipping.

The Sheboygan Co. Highway Department has given an estimate to chip seal Sexton Road between County Highway H and Sheboygan Road and Holstein Road between County Highway H and Sheboygan Road. Sexton Road would cost \$300 patch prior to chip seal and the chip seal would cost \$16,695. Holstein Road would cost \$700 prior to chip seal and the chip seal would cost \$17,123. The county work is done on a time and material basis. Other estimates will be asked of other companies.

It was discussed if the ditch on Holstein Road should be cleaned out first. An estimate will be taken to see if the Town could afford to do all this work.

Michael Braun will be asked if he will cut the grass by the town hall this year.

No members of the St. Anna Fire Department attended the meeting.

Ann Hickman, real estate for Jose Paredes, could not attend the meeting. They would like to sell 20 acres with improvements. This would have to be rezoned to A2. The rest of the land would stay as A1. The person buying the farm land would be buying a 66 foot driveway back to the farm land.

Lane Baxter is interested in buying David DeVillers property. He would like to replace the mobil home with an 850 square foot prebuilt home. The town board saw no problem with this.

The town board discussed if the town should look for an attorney that knows town law.

The clerk contract was reviewed by the town board. Schmahl moved to accept the contract. Ausloos seconds the motion. Motion carried. The board signed the contract.

The liquor license applications of David DeAngelico and Scott McMurray of the Marsh Lodge and Brandon Jovanovich of JOVANS' were reviewed by the board. Ausloos moved to have the liquor license application published. Schmahl seconds the motion. Motion carried.

The planning board is working on the ordinance manual. The public meeting will be held later this year.

The monthly bills were presented to the board. Ausloos moved to pay all the bills. Schmahl seconds the motion. Motion carried.

No building permits were issued in the last month.

The recycling center was discussed. The clerk reported that he had received a letter from the DNR that closed Town of Russell Landfill, License Number 557, is now in compliance.

The constable reported that one town individual has paid his dog license in Calumet County. He lives with his sister in Calumet County even though he owns a house in Town of Russell. Two other individuals have been reported to the County District Attorney.

The Elkhart Lake Triathlon will be held on Saturday, June 13, 2015. Some of the bike race will go through the Town of Russell. The clerk and Jeff Grady checked the bike route for pot holes. There were some on Holstein Rd.

The town roads were discussed. The fire number signs should be received by the end of the month. The town has received some bids for work on Holstein Rd. and Sexton Rd. Sheboygan County Highway Department had given as estimate of \$107,500.00. They did not break down the estimate.

Scott Construction has given a bid for Sexton Rd. Option 1 was hot oil seal coat with a stone cover aggregate for \$17,600.00. Option 2 was hot oil seal coat with a black slag

cover aggregate for \$18,500.00. Holstein Rd. Option 1 was hot oil seal coat with a stone cover aggregate for \$38,950.00. Option 2 was hot oil seal coat with a black slag cover aggregate for \$37,752.00.

Struck & Irwin Paving, INC has given a bid for Holstein Rd. Option 1 was for \$29,363.35 and Option 2 for \$31,918.35. Bids for Sexton Rd. Option 1 was \$28,501.60 and Option 2 was for \$30,980.00.
