The meeting was called to order by Chairman Terrance Winkel at 6:00p, m, with the Town Board present plus Gary Fischer of Rural Insurance, Bill Glatz of Fahmer Asphalt Sealers and Colleen Schnell. The meeting was posted to start at 6:00p.m. because Gary and Bill had requested this time.

The Pledge of Allegiance followed.

The clerk verified the agenda was posted.

The minutes of the previous monthly meeting were read. Schmahl move to accept the minutes as read. Winkel seconds the motion. Motion carried. Gary Fisher of Rural Insurance explained insurance protection that starts May 1, 2016. He explained that cyber liability coverage was included in the policy for \$39.00. Kenneth Turba, building inspector, who issues the building permits, would like to retire. Jerrod Henschel is to be zoning administrator after the Zoning Ordinance is done. A building permit issuer will be posted in the post boxes.
